



# 29th Annual Base-Bowl Tournament July 24-25, 2010



**FORMAT:** Open to all Co-Rec/Co-Ed baseball teams. Men's or Women's team may enter as long as they pick up additional player to meet Co-Rec requirements. Each baseball team will play 3 games of baseball. In addition each baseball team will make up (2) bowling teams comprised of 3 men and 2 women or 2 men and 3 women. Each bowling team will bowl 3 games. Each baseball win will be worth 2 points and each bowling win will be worth 1 point. Players from the baseball teams will be assigned to one of the two bowling teams and may not switch during the tournament. Trophies will be awarded to 1st and 2nd place teams, more depending upon number of teams entered. Individual awards will be presented to the 1st place team. In case of a tie, for any trophy position a 1 game roll off will be bowled using a modified baker system.

**BASEBALL RULES:** Mushballs will be used for all baseball games and all balls will be provided. Umpires will be provided by the tournament. In an emergency teams not playing may be asked to provide and umpire. Rules will coincide with current Co-Rec rules with the following exceptions: Fouls on 3rd strike is not an out -- 15 run rule after 5 innings -- 1 hour and 15 minute time limit.

**BOWLING RULES:** Handicap will be 80% of the difference between the individuals average and 210. Maximum pins per game for women will be 75 and 60 for men. Averages will be the highest 2009-2010 winter league average or previous year's average. Those with no average will establish an average during the tournament.
